Nomination Forms duly completed and signed must be forwarded to the Chief Executive Officer, [ceo@fsc.com.au](mailto:ceo@fsc.com.au) PO Box 860, Fremantle 6959, or handed in at the Club Office to arrive no later than **5pm 18 June 2024**. An individual may be nominated for more than one position however a separate nomination form should be completed for each nomination.
3. Candidates are to submit a passport size photograph and a typed statement including the candidate's background and objectives, their reasons for seeking election and may include contact details to facilitate direct communication. Each candidate shall ensure that the contents of their statement are true and correct and do not refer directly or indirectly, to any other candidate except to state that such person has nominated or seconded each candidate. The statement must not exceed 500 words, and will not be accepted for inclusion in the special election booklet after the close of nominations.
4. Successful candidates will be expected to complete "Committee and Board Compliance Certificate" within 6 weeks.
